## THE JOURNEY BEGINS... THE FIRST SIX MONTHS

IN THIS INTERVIEW DAVID ROBINSON, ONE OF THE FIVE TRUSTEES OF MARY AIKENHEAD MINISTRIES, IS ASKED TO REFLECT ON HIS FIRST SIX MONTH'S EXPERIENCE AS A TRUSTEE.

JOURNEYS: Many readers may wonder what is it that you actually do as a Trustee?

DAVID: Well we should start with the fundamental premise: I am one of five Trustees who are stewards of the ministries of Mary Aikenhead Ministries in canon and civil law, responsible for the governance and management of Mary Aikenhead Ministries and accountable to the Member of Mary Aikenhead Ministries (who is the Congregation of the Sisters of Charity) and to the Holy See.

To use a cliché you could say the "buck stops here". While we have a chairman of Trustees in Richard Harpham, all the Trustees are equally accountable. From a practical view point my activities could be distilled down to two areas: that of discernment and relationships. By discernment, I mean reading and considering a lot of information, and input from many talented people, sharing views with my fellow Trustees and affirming and working with the challenges presented and making decisions. By relationships, I mean it is a deliberate and necessary undertaking to foster understanding of our mission through engagement with as many people as possible.

JOURNEYS: This seems like a significant time commitment?

DAVID: It is, and I must say this is a challenging balancing act at times. My role as Trustee is part time. I have commitments in my Chartered Accounting practice, the corporations for which I act as a director and of course my most significant commitment to my family of young adults and my very understanding wife, Ann. But I view my role as a Trustee as a ministry of the Church – it's not about utilising some spare time – it's about participating as a lay person in the Church. The Sisters of Charity and Mary Aikenhead Ministries have enabled me to contribute to the life of the Church.

JOURNEYS: Did you have expectations prior to accepting the role as Trustee?

DAVID: There were no expectations from my side per se. This is a new journey for all. I was privileged to accept the invitation to become a Trustee in late 2008 and spent the time until last July as a 'Trustee in waiting'. This was an opportunity to share in the implementation of the decision by the Congregation to create Mary Aikenhead Ministries. For the Trustees, it was a time to learn a lot about each other and share our personal experiences of Church and life.

JOURNEYS: Was there a process of Formation for your role as a Trustee?

DAVID: My faith journey began with my baptism, my family upbringing and my initial educational experience with the Sisters of Charity at Lewisham. My formation has been as a lay person not as a religious – a different journey, but I believe just as rich. It continues. Formation is an essential element of my personal development and essential to the development of those engaged in Mary Aikenhead Ministries. We see our role as Trustees as ensuring all engaged in the ministries have opportunities for formation. This will be a critical theme for the TMAM/TSCA sponsored conference in July, which I look forward to very much. As a Trustee I have been privileged to have opportunities to deepen my relationship with God through retreat, the presence of the Trustees' spiritual companion at our meetings, sharing of our lives with fellow Trustees and much personal reflection – I can assure you this does have an impact on your personal spirituality.

**JOURNEYS:** What have been the highlights of your first six months as a Trustee?

DAVID: There have been many. The Commissioning and Blessing of the Trustees was a special moment in my life, shared with my family, friends and members of the Congregation. The many other moments relate to the engagement I have had with people involved in the Ministries. I have witnessed so much evidence of the dedicated work of those in the ministries. The ABC provided an example of this with the 4 Corners program on 8 February with its story based at the Sacred Heart Hospice in Sydney.

JOURNEYS: Have there been difficult issues during your first six months?

DAVID: To use an expression of a valued colleague... there have been some "Gethsemane moments". But this is the case with any organisation, and especially a new organization created by a forward thinking, proactive group such as the Sisters of Charity. But like Mary Aikenhead and her successors we will discern carefully. Perhaps some decisions we have made and will make will not be easily understood or accepted by some – but those involved in our ministries can be assured those decisions are the result of tremendous energy, thought and prayer.

JOURNEYS: Finally, David what is your vision for Mary Aikenhead Ministries in 20 years?

DAVID: I see Mary Aikenhead Ministries as a vibrant lay/religious partnership within the Church with thriving ministries in Health, Education and Welfare – in whatever forms they may be conducted in that future age. There will be other Congregations who would have transferred their ministries to Mary Aikenhead Ministries. While Mary Aikenhead Ministries will be very much part of the Church, it will have retained its unique place and the special 'story' and mission founded by Mary Aikenhead and carried on by the Sisters of Charity, will have an additional chapter, long since created and developed through Mary Aikenhead Ministries.

Celebrate the first anniversary of the establishment of Mary Aikenhead Ministries with '*The Heart of Our Journey*' Conference – the inaugural conference of Mary Aikenhead Ministries. Set to unite leaders in the exploration of stewardship and the call to serve the poor and marginalised, '*The Heart of Our Journey*' will take place at the Novotel Brighton-Le-Sands, Sydney, on Thursday 22 and Friday 23 July 2010.

For leaders in the ministries of health, education and welfare, 'The Heart of Our Journey' will revisit the establishment of Mary Aikenhead Ministries and will illustrate how the story of innovation, courage and conviction is set to grow into the future.

"Education in theology, scripture and ethics are essential elements of the ministry of lay leadership, especially for directors and executives. The conference is set to educate and further inspire those who lead our ministries. Not only a learning opportunity, the conference will connect leaders from across Australia and reinforce the importance of dialogue and collaboration," explains Sr Elizabeth Dodds, Trustee, Mary Aikenhead Ministries.

Keynote speaker, Sr Kathleen Bryant, will address issues surrounding the alignment of services within Catholic identity and secular society. Sr Kathleen Bryant will speak of the opportunities that evolve in ministries and how to seize such opportunities. Having entered the Religious Sisters of Charity in 1967, Sr Kathleen Bryant has worked as far afield as Namwala, Zambia, and was until recently, the Director of Seminarians, Archdiocese of Los Angeles. She completed a Doctorate and Masters Degree in Spirituality in 1990 and a Doctor of Ministry Degree in 1995.

'The Heart of Our Journey' will commence at 5pm, Thursday 22 July with a Eucharistic celebration at St Thomas More Catholic Church, 298 Bay Street, Brighton-Le-Sands, and will be followed by a formal conference dinner at the Novotel Brighton-Le-Sands (a location map is included on page 4 of this newsletter).
