MARY AIKENHEAD EDUCATION OPENS NATIONAL OFFICE IN BRISBANE

Mary Aikenhead Education, the entity recently established by the Trustees of Mary Aikenhead Ministries to operate its education ministry in Australia, officially opened a national administration office at the Lavalla Centre, Rosalie in Brisbane on 5 October.

Mary Aikenhead Education has four Catholic girls' secondary colleges within its national system. These include Mt St Michael's College at Ashgrove, along with Catholic Ladies College and St Columba's College in Melbourne, and St Vincent's College in Sydney.

Chair of Mary Aikenhead Education, Mr Pat Mullins said the opening of the office was a significant milestone in the journey of establishment of the new entity.

"The decision to establish Mary Aikenhead Education as an entity was not taken lightly and to see it come to fruition has been a credit to the commitment and hard work of many people. Mary Aikenhead Education encourages collaboration in mission. Such collaboration is the future of the Church.

The opening of this office now represents a further step toward placing this collaborative education ministry on a sure footing for the future," he said.

Trustee of Mary Aikenhead Ministries, Sr Elizabeth Dodds rsc, congratulated the Directors on their efforts over the past fifteen months, saying:

"I am extremely proud of and grateful for what has been achieved in such a short time.

This office, under the leadership of Executive Officer, Judith Gardiner, will not only provide vital support services for our schools, but will also be a focal point for promoting the mission of the Church through Mary Aikenhead Education".

DISCERNING A NEW Leadership Model in Health A trustee's perspective



"The change in leadership model will strengthen the organisation and provide new opportunities."

The commissioning of the new National Board of Directors of St Vincent's Health Australia on 1 October 2010 was the culmination of an intense and highly professional governance review process involving consultation, acknowledgement of invaluable contributions, care and respect.

In November 2009, the National Board, with the consent of the Trustees of Mary Aikenhead Ministries, engaged an international consultancy firm, McKinsey & Company, to facilitate a governance review.

A 'Sponsor Group' consisting of national and regional board members was nominated in December and met for the first time in January 2010, continuing until April 2010. The time, effort and expertise contributed by this group cannot be overstated.

The review methodology was reasonably simple, even textbook in nature: understand the current situation, determine the goals and evaluation criteria, name the options (including maintaining the status quo), evaluate the options against the criteria and then make the decision. Underpinning this methodology from the Trustees' perspective however was discernment involving prayer, reflection, feelings, debate, listening, searching...

The information gathering process led by McKinsey & Company delved deeply into the organisation. Many interviews with members of the Congregation, Trustees, board members, executives and SVHA staff and our valued joint venture partners were conducted. By February 2010, the Sponsor Group had developed criteria against which the governance options could be evaluated.

The final recommendation of the Sponsor Group and Board can be summarised as a move to a single fiduciary National Board while maintaining three strong, focused regional community advisory boards, and strengthening management resources and capabilities. Regional CEOs will report to the National CEO, rather than reporting to their respective regional boards.

The Trustees accepted this recommendation at their April 2010 meeting. A challenging implementation phase then commenced. The acceptance of this decision, by existing regional and national Board members, was remarkable. It remains a testament to the values lived within the health ministry that Board members would readily resign, sacrificing their personal positions for the betterment of the mission and then offer to assist in any capacity required. This would be difficult to contemplate in the corporate world.

For the Trustees of Mary Aikenhead Ministries the significant task became discernment around the National Board director selection process. The Trustees saw this task as one of the most important they would ever undertake, especially as many existing directors had expressed interest in becoming a director on the new National Board. Trustees participated in each interview with approximately 20 candidates. The Trustees were privileged to interview such highly skilled and talented people. Their commitment to the mission we all share was palpable. The most difficult element was the final selection of directors.

As Trustees, we observe that SVHA is an inspirational and incredible organisation with dedicated people at all levels committed to excellence, living and breathing its mission. The change in leadership model will strengthen the organisation and provide new opportunities. There will be ongoing challenges, not the least of which will be protecting existing strengths in maintaining local relationships and focus on values and mission. We have confidence the challenges will be met and SVHA will fulfill its potential. I struggle to find words which could adequately express the deep appreciation and admiration for those members of the health ministry and their advisors who shared the gift of themselves in this process.

Recently the Trustees of Mary Aikenhead Ministries invited the Directors of the St Vincent's Health Australia Board and the National CEO to participate in a process of formation at the Marriot Hotel, Sydney. Richard Harpham, the Chair of Mary Aikenhead Ministries set the context for the day and introduced the two presenters.

Dr Michele Connolly rsj broke open the Scriptures around the theme 'Tapping Jacob's Well: Drawing the Waters That Refresh Us.' Michele's scholarship and engaging style enabled all present to reflect on the conversation between Jesus and the Samaritan woman and apply this to ways in which our core values of love, hope, compassion and justice are woven within this story.

PHILOSOPHY OF EDUCATION Promulgated

After an extensive period of consultation throughout our ministries, the Trustees have promulgated a philosophy of education for Mary Aikenhead Ministries.

Margaret Stewart of Prism Australia, widely consulted executives and directors across the ministries within health and education, and together with the Trustees has drawn up the philosophy along with a Charter for Implementation. It is based on the Education Philosophy of the Sisters of Charity and that of the Sisters of Charity of Australia. As requested within our MAM Constitutions, the philosophy embraces not only our colleges but also our health, aged care, research institutes and welfare facilities. Promulgated by the Trustees, the philosophy is a vital and complementary component of the foundational documents in the Petition which established Mary Aikenhead Ministries. The philosophy is both aspirational and invitational, and will be presented at the November meetings among the Trustees, Mary Aikenhead Education and St Vincent's Health Australia. After these meetings the philosophy will be distributed to our Boards and Directors. Our thanks to all who participated.
